2. New features

2.1. Justify a high risk contact for company doctors

Company doctors have to justify a prescription for the reason high risk contact.

Before: indicating the SSIN of the positive person was mandatory.

Now: the company doctor can now fill a form when:

- the application cannot find the positive result of the person
- or the SSIN of the positive person is unknown
- or the person has not been tested in Belgium.

2.2. Generate a CSV file with dashboard content

It is now possible to generate a CSV file with the content of the dashboard. The content of the CSV file will be filtered just as the dashboard is filtered at the moment of the generation request.

The file can be downloaded only once on the new "My Exports" tab. A user can generate as many CSV file as necessary.

2.3. Dashboard – New filters

3 new filters are now available :

- 1. State of the prescription code
- 2. Sampling id
- 3. Prescriber



2.3.1. State of the prescription code

The dashboard can be filtered depending on which state are the prescription codes.

A user can filter prescription code by:

- Test result is still to be sent
- Sample is still to be taken
- Sample has been sent to a laboratory for analysis

2.3.2. Sampling Id

The dashboard can be filtered to find prescription codes based on a sample id.

2.3.3. Prescriber

The dashboard can be filtered to find prescription codes created by a specific prescriber for the selected collectivity/enterprise.

2.4. Contact information

The CTPC helpdesk is not entitled to answer all the questions about the COVID-19 testing.

To help the users, we updated the content of the contact information page accessible on the upper right corner of the web application.

The page provides contact information regarding:

- Logistics (pickup and delivery)
- Test strategy of the several regions
- Test results
- Technical issues with the Corona Test Prescription & Consultation (CTPC helpdesk)
