2. New features

2.1. Script 1A – Automatic filling of the address of the cohabitant's index patient

When adding a cohabitant as a risk contact of the index patient, the address of the cohabitant will be automatically filled in with the data of the index patient. The fields will remain editable.

The second part of this change request "add a "cohabitant flag on script 2A, 2B and 3B" will be done for the March 11th release.

2.2. Script 1A – Hide the button for manually adding a new collectivity

In the step "Collectivity" of script 1A, the button for manually adding a new entity will be hidden by default. A keyboard shortcut (communicated outside of the Release Note) allows to show / hide the button again to use the feature.

The manual add feature remains available for Organization part.

2.3. All Scripts – Entity responsible for personal data displayed by region

The entity responsible for personal data is displayed according to the region at the beginning of the script:

- VLG → Agentschap Zorg en Gezondheid
- BRU → COCOM
- WAL \rightarrow AVIQ
- DEU (OST) → Die Deutschsprachige Gemeinschaft

2.4. Scripts 1A, 2A, 2C, 2B – modification of questions on vaccination

- The question on the planning of the 2nd vaccination is masked if the citizen answered having already received 2 injections.
- Modification of FR copy "Avez-vous déjà pris rendez-vous pour vous faire vacciner contre le COVID19?" (1A-Q10G, 2A-Q7G, 2C-Q10G, 2B-Q5G)

2.5. Script 1B - Moving the data to the collectivity's region

The "Region" data is moved from the "patient information" zone to the "collectivity" zone for more consistency.
