2. Updated features

2.1. Business rules modifications

2.1.1. Activate By Ssin

The minimum age for the activation has been changed from 16 to 12 years.

2.1.2. List Schedulable

The minimum age of the returned people has been changed from 16 to 12 years.

2.1.3. Last minute booking eligibility

People aged 12 to 18 are now eligible to the last minute booking if they have an activated vaccination code.

The logic for the second run has been implemented.

A person is eligible to the last minute booking for the next run, if :

- A normal notification was sent 28 days ago
- There is no schedule or a schedule 14 days ago

The other conditions for being eligible remain applicable.

2.1.4. Free test eligibility

If a citizen is invited a second time (run 2) for the vaccination, he is no longer eligible for a free test. The number of days in many conditions has been changed (see below).

Due to the fact that people may have encountered difficulties in getting vaccinated between July 15 and July 21 due to the floods, an extension of the time periods (indicated in green below) has been set.

A free PCR test can be obtained twice if the following conditions are met (in red the changes compared to the previous release) :

1. the person to be tested is 6 years or older and
2. has his main residence in Belgium according to the information in the National Register and
3. has not already obtained a CTPC for a free test twice and
4. is in one of the following cases at the time of the request for a CTPC for a free test
 - a. the person has not been invited yet for vaccination and not been (partially) vaccinated yet
 - b. the person has been invited, **only one time**, for vaccination no longer than **35** days ago (less than 42 days ago if the person has been invited between June 10 and June 16)

- c. the person has received a first of two required doses **within 35 days after the invitation** (within 42 days after the invitation if the person has been invited between June 10 and June 16) and no longer than
 - i. 98 or 70 days ago for AstraZeneca, depending on whether the first dose was given before May 26 or May 26 onwards (105 days ago if the person has been invited between April 22 and April 28 or 77 days ago if the person has been invited on May 26)
 - ii. 49 days ago for Moderna (56 days ago if the person has been invited between June 10 and June 16)
 - iii. **49 or 35 days ago for Pfizer, depending on whether the first dose was given before July 14 or July 14 onwards** (56 days ago if the person has been invited between June 10 and June 16)
- d. the person has received a dose of Johnson & Johnson **within 35 days after the invitation** (within 42 days after the invitation if the person has been invited between June 10 and June 16) and no longer than **28** days ago.

2.2. API modifications

2.2.1. OlderThan parameter

The limit of the parameter “OlderThan” in the methods “listSchedulable” and “bulkActivationByOldest” has been changed from 16 to 12.

2.2.2. Second run

In the method “listSchedulable”, the parameter “maximumNotificationRunLimit” cannot be greater than 2.

In the method “isEligible”, if “schedulableForNotificationRun” is greater than 2, this method returns “false” for the eligibility.

If the eligibility is false, this method does not return the field “schedulableForNotificationRun”.

If a person is not eligible and has a schedule or a notification, the value of the “ineligibilityDurability” field is no longer “FINAL” but “TEMPORARY”. Indeed, after a certain time, he will be eligible for the second run.
