2. New features

2.1. CR158 & 159 – Update of “contact type” to determine rules for High Risk contact under 12 years old

Impacted scripts : 1A, 2A, 1A HH

ADDITION OF THE CONTACT TYPE FOR PATIENTS AGED 12 AND +

In script 1A, the contact type “**Similar to household contact (eg: pyjama party)** » is now also displayed when the index patient is 12 years or older.

Just as index patient under 12y contacts, this contact type will automatically be classified as a High Risk contact.

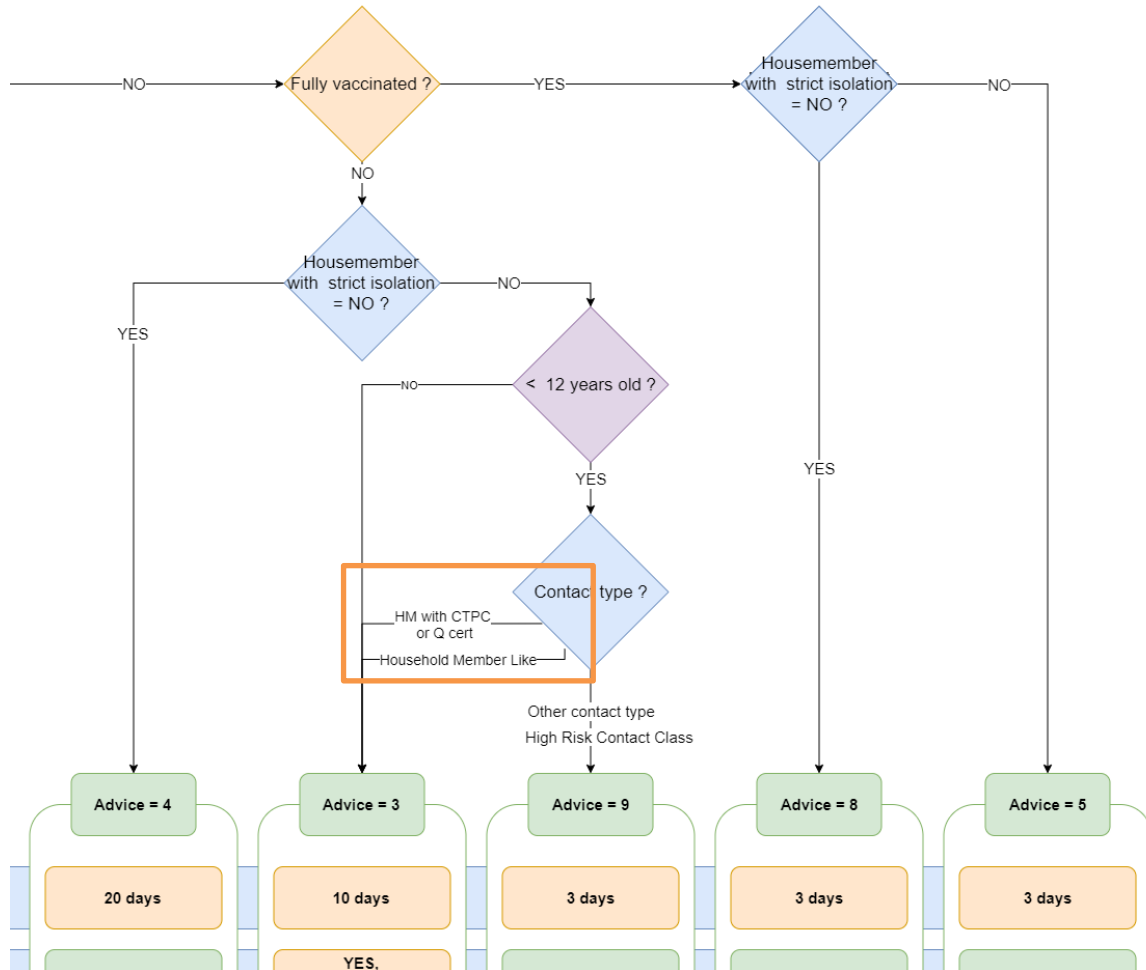

CHECK ON NEW CONTACT TYPE IN RULES FOR HRC UNDER 12

In script 2A (and 1A HH), when the high-risk contact is less than 12 years old, the check is now also made on the contact type **“Cohabitant who needs quarantine certificate and PCR codes”** entered during the interview 1A to determine the Advice to follow by the citizen (Advice 3).



DIRECT TREATMENT OF THE COHABITANT

The question with the proposal to process a contact directly via the script 1A HH is only proposed if the selected “contact type” is **“Cohabitant who needs quarantine certificate and PCR codes”**.

2.2. Tracing of COVID cases for schools in Brussels via 1A script

Impacted scripts : 1A, 2A

ADDITION OF THE CONTACT TYPE “HIGH RISK CONTACT CLASS”

In script 1A, the contact type “**High Risk Contact Class (BRU/WAL ONLY)**” is now displayed when the index patient is under 12y.

This contact type will automatically be classified as a High Risk contact.

CHECK ON CONTACT TYPE IN RULES FOR HRC UNDER 12

In script 2A (and 1A HH), when the high-risk contact is less than 12 years old, the check is now also made on the contact type “**High Risk Contact Class (BRU/WAL Only)**” entered during the interview 1A to determine the Advice to follow by the citizen (Advice 9).
